

## **General Conditions of Sale**

Between SARL CAX (AUBERGE DU CHEVAL BLANC), 11 PLACE DE LA MAIRIE 52410 CHAMOUILLEY with share capital of 7,622.45 €, registered in the Trade and Companies Register under the number 490136546, and whose SIRET number is 42286780400011, represented by Mr. Céline SCHROBILTGEN as manager, duly empowered for the purposes hereof. The company can be reached by email by clicking on the contact form accessible via the home page of the site or via the Contact section.

Here in after the Seller or the Company on the one hand, and the natural or legal person purchasing the products or services of the company, hereinafter, the Buyer or the Customer on the other hand (The person using the gift voucher is called "The Beneficiary"), It has been stated and agreed as follows:

### **PREAMBLE**

The Seller offers gift vouchers valid in his establishment AUBERGE DU CHEVAL BLANC 11 PLACE DE LA MAIRIE 52410 CHAMOUILLEY (for consumers, marketed through its website (<https://www.auberge-duchevalblanc.fr/>)). The list and description of the goods and services offered by the Company may be viewed on the aforementioned sites.

These Conditions exclusively govern the use (printing, payment and use) of gift vouchers to be printed presented on the website [www.auberge-duchevalblanc.fr](http://www.auberge-duchevalblanc.fr). The Parties agree that their relations are exclusively governed by these Conditions. Prior to any printing, the Customer acknowledges having read them and declares to accept them as soon as he clicks on the box relating to his General Conditions of Sale and the printing of gift vouchers.

Any printing implies acceptance of these general conditions of sale.

### **Article 1: Validity of the gift voucher**

The validity of the gift voucher in the store is not definitively confirmed and commits the Seller only upon receipt by the Customer and the Beneficiary of a confirmation e-mail sent to him by the seller after receipt of the check and collection. of the regulations. The gift voucher is only valid at the seller's points of sale, the contact details of which are specified on the contact page of the seller's website.

### **Article 2: Payment of the gift voucher**

The only currency accepted by the seller is the euro. Payment of the gift voucher is made by check by returning the copy intended for AUBERGE DU CHEVAL BLANC, 11 PLACE DE LA MAIRIE 52410 CHAMOUILLEY accompanied by the payment check corresponding to the amount indicated on the two copies of the gift vouchers.

### **Article 3: Value of the Gift voucher**

The value of the gift voucher is indicated on the chosen voucher and printed by the user. The payment check sent by the customer for payment of the gift voucher must therefore be established at the amount corresponding to this service (Amount specified on the gift voucher) so that the gift voucher can be considered valid.

Without these conditions, the copies of the gift voucher and its payment cannot be considered valid.

#### **Article 4: Activation and Expiration of the gift voucher**

The gift voucher is considered activated only after receipt and collection of payment. The Gift Voucher is valid for 1 year from this date.

#### **Article 5: Validity of the information provided**

It is the customer's responsibility to check the validity and readability of the information provided (emails, telephone numbers, etc.). Without this, the seller cannot confirm the activation of the gift voucher.

#### **Article 6: Withdrawal period**

In accordance with the Consumer Code, the Customer has a withdrawal period of 14 days from receipt of the order confirmation by email. However, if the Gift Voucher were to be used, even partially, in this time interval, this withdrawal period would be considered to have lapsed.

The seller undertakes to reimburse him the gift voucher within 14 days from the date of receipt of his request. The customer must return the copy of the gift voucher to offer and a bank account number by registered mail with AUBERGE DU CHEVAL BLANC, 11 PLACE DE LA MAIRIE 52410 CHAMOUILLEY. Only the face value of the gift voucher is reimbursed, any shipping and return costs are the responsibility of the Customer.

#### **Article 7: Use of the gift voucher by the Beneficiary**

The gift voucher is used at once and cannot be broken (cannot be used more than once) and cannot be exchanged or refunded.

The gift voucher is valid for 1 year from the date of purchase, after this period it can neither be refunded nor exchanged and it can no longer be accepted by the seller.

The Beneficiary can only use the gift voucher for the payment of goods or services acquired from the Seller, being provided with his gift voucher. When presenting the gift voucher, the Seller authorizes himself to verify the validity of the coupon and this by all the means at its disposal:

- The numbering of the gift voucher must correspond with that of the coupon received by the Seller

- The identity of the person must correspond to that indicated on the returned coupon

The seller's gift voucher cannot be exchanged, resold or reimbursed, even partially, or credited to a card or bank account, or be subject to a discount. It cannot be replaced in the event of loss, theft or expiry. It cannot be the subject of a request for opposition.

Any order and printing implies acceptance of these general conditions of sale.
